This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner-Accused No.3 to quash the proceedings against him in Crime No.462 of 2022 pending on the file of Station House Officer, Musheerabad Police Station, Hyderabad. The offences alleged against him are under Section 8(c) read with 20(b)(ii)(B) of NDPS Act, 1985.
