heroby is decreased from Rs.12,76,010/- to Rs.11,34,198/- (Eleven Lakhs
Thirty Four Thousand One Hundred and Ninety Eight Only) with interest at

- 7.5% per annum from the date of petition till the date of payment, paid by both the respondents jointly and severally;
3. That the awarded amount shall be apportioned in the manner as ordered by the Tribunal;
 4. That save as aforesaid, the decree of the Lower Court shall stand confirmed in all other respects; and
 5. That there shall be no order as to costs.

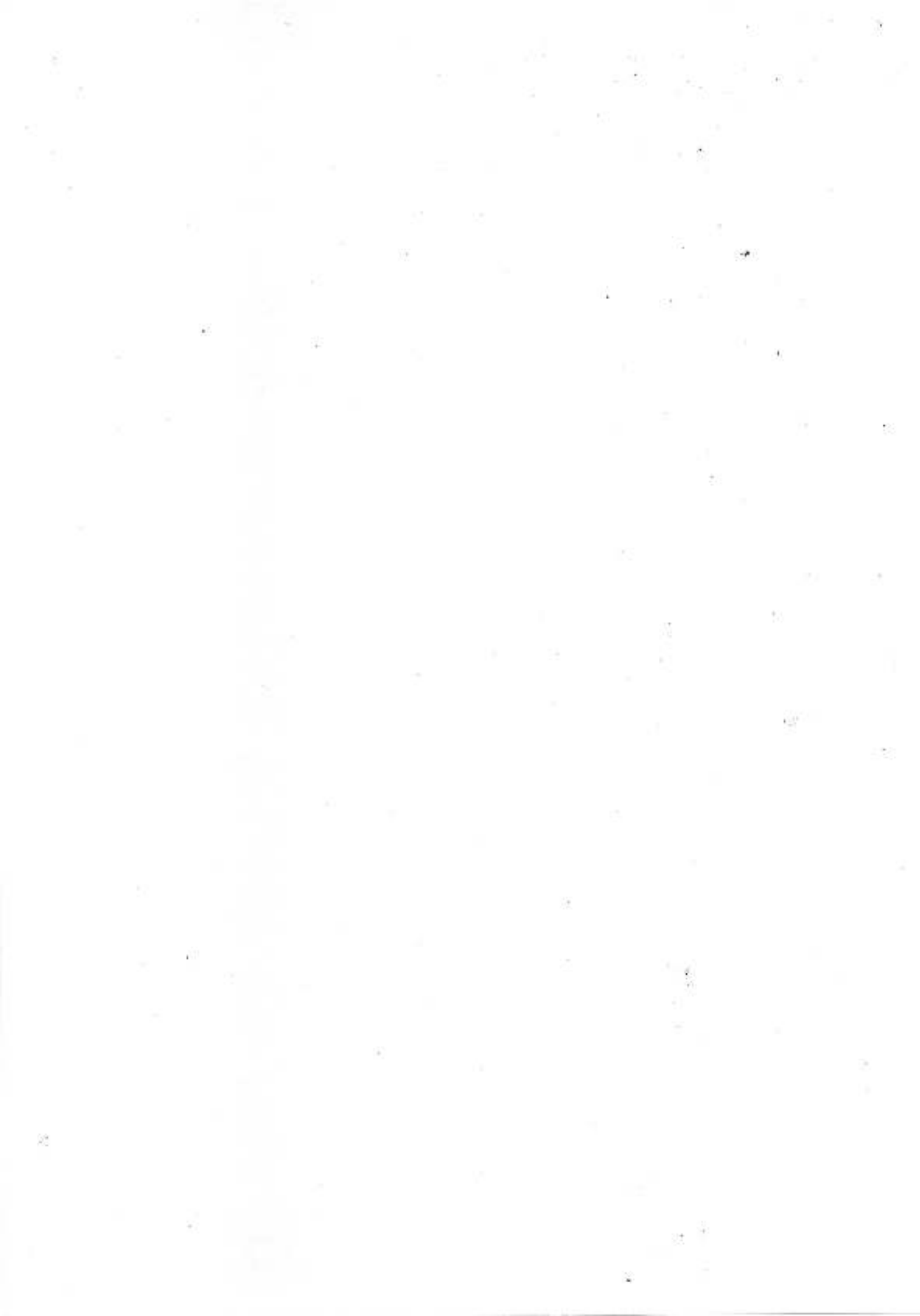
