This common order shall dispose of above noted four petitions as they arise out of the same FIR.

Prayer in these petitions is for quashing of FIR No. RC0052020A0004 dated 10.06.2020, registered under Sections 420, 120-B of the IPC and Sections 13(2) read with Section 13(1)(D) of the Prevention of Corruption Act, 1988 at Police Station ACB, Chandigarh, Sector 30, Chandigarh along with all the subsequent proceedings arising therefrom.

Learned counsel for the petitioners submit that all the petitioners have appeared before the trial Court and they have been released on bail. It is further submitted that the case is now fixed for 06.04.2022 for arguments on framing of charge.

Learned counsel further submit that petitioners will move an application for discharge along with all the supporting documents.

In view of the above, the present petitions are disposed of.

In case the petitioners move an application seeking discharge within a period of 15 days from today, the trial Court shall decide the same by taking into consideration the documents submitted by the petitioners.

Liberty is granted to petitioners to file a fresh petition, if any

adverse order is passed.
