[1] Case is being taken up for hearing through Video Conferencing due to Covid-19 pandemic.

[2] Learned counsel states that the grievance of the petitioner, as is the subject-matter of the writ petition stands redressed, as the petitioner was called for re-measurement of his height. However, even in the re-measurement carried out, the height of the petitioner has not been found to be as per requirement stipulated under the rules.

[3] Learned Counsel states that in the circumstances, the petitioner is not interested in pursuing the writ petition and may be permitted to withdraw the instant petition with liberty to challenge the decision of the respondents, declaring the petitioner as not meeting the stipulated height requirement even on re-measurement by way of appropriate proceedings, in accordance with law.

[4] In view of the position noted above, as well as statement of learned counsel for the petitioner, the instant petition is *dismissed as withdrawn* with the liberty, as prayed for.
