CR No.588 of 2022

By way of the instant petition, the petitioners have assailed the order dated 15.12.2021 (Annexure P-3) passed by learned District Judge, Kapurthala, whereby the application, as preferred by them for seeking the transfer of the Civil Suit titled as “***Sukhdev Singh & Ors. Vs. Malkit Singh & Ors***”, pending in the Court of the Civil Judge (Junior Division) at Sultanpur Lodhi, District Kapurthala, to any other competent Court outside the above-said Sub-Division, has been dismissed.

2. Learned counsel for respondents No.1 to 7 submits that his clients have no objection in transferring the afore-said Civil Suit from Sultanpur Lodhi to any competent Court at Kapurthala.

3. Keeping in view the above-discussed facts and circumstances, the revision petition in hand is hereby allowed and the afore-referred Civil Suit is withdrawn and transferred from the Court of learned Civil Judge (Junior Division) Sultanpur Lodhi with the direction to learned District Judge, Kapurthala to assign the same to the Court of competent jurisdiction at Kapurthala, for being decided in accordance with law. The parties, through their respective counsel, are directed to appear before the assignee Court at Kapurthala on 10.01.2023.
