The instant petition has been filed under Section 482 of the Code of Criminal Procedure with a prayer to conduct free and fair independent inquiry/investigation with a further direction to the respondent authorities to effect arrest of respondent Nos.5 and 6 in case FIR No.243 dated 10.10.2021 under Sections 302 and 34 of the Indian Penal Code, 1860 registered at Police Station Gate Hakima, District Amritsar.

Pursuant to issuance of notice of motion, status report by way of affidavit of Kanwalpreet Singh, PPS, Assistant Commissioner of Police, Central, Amritsar City has been filed. Copy thereof has been furnished to the counsel for the petitioner. The relevant extract of the said status report is reproduced as under:-

3. That during investigation complainant presented MLR no.25/CHASR/MLC/ SEP 2021 in which Doctor observed both the injuries which were inflicted upon the deceased were caused by blunt weapons and in the VISCRA report of the

deceased it was observed by the doctors that all the injuries which were sustained by the deceased are ANTEMORTEM and as a result of blunt force death was caused. That during further investigation and upon receiving of reports both the accused person Baba Basanta Singh s/o Late Gurdial Singh and Kuldeep Singh Pinka s/o Paramjit Singh were got arrested on 7.04.2022 and during the interrogation accused persons in their disclosure statement stated that on 21.09.2021 they injured Sikander Sing by hitting him with stones and bricks and ran away from the spot. That both the accused persons were presented before the court of Illaqa Magistrate Ms. Sukhpreet Kaur JMIC Amritsar and manage to get one day police remand of both the accused persons and on 09.04.2022 both the accused persons were again presented before the court of Sh. Vishav Gupta JMIC Amritsar and were sent to judicial custody Central Jail Amritsar till 23.04.2022.

- 4. That the challan is ready to be presented in the court of Illaqa Magistrate Ms. Sukhpreet Kaur JMIC Amritsar and the next date of hearing before the Illaqa Magistrate is 23.04.2022.*

In view of the averments noticed above and the fact that the accused persons namely Baba Basanta Singh and Kuldeep Singh Pinka have already been arrested and final report under Section 173 CrPC is in the stage of being filed before the Illaqa Magistrate in a short duration, learned counsel for the petitioner does not press the instant petition.

Dismissed as not pressed at this stage.
