In compliance with the order passed by this Court on 18.05.2022, affidavit of SDO (C)-cum-Assistant Collector First Grade, Rewari, dated 18.05.2022, has been filed in Court, which is taken on record.

In paras No.2, 3 and 4 thereof, it has been stated as follows:-

“ 2. That in order to make compliance of above directions of Hon'ble High Court, the deponent vide office Memo No 1015/Peshi dated 24-06-2022 (Annexure-R1) issued direction to Naib Tehsildar, Palhawas to remove the encroachment of petitioner from Khasra No. 254 and handover the possession to Panchayat. Direction were also issued to Block Development and Panchayat Officer, Jatusana to co-operate, and provide resources to Naib Tehsildar, Palhawas during proceeding of above removal of encroachment and also to initiate the proceeding to remove encroachment of other persons from Panchayat Land reflected in demarcation report dated 10-05-2022

as per Law.

3. That as per report dated 07-07-2022 of Halqa Girdawar duly counter signed by Naib Tehsildar, Palhawas (Annexure-R2). The encroachment of the petitioner of 29.5 Sq. Yard in Khasra No. 254 has been completely removed by the petitioner himself. The site was inspected and compared with demarcation report dated 10-05-2022 on 07-07-2022 by Halqa Patwari, Halqa Girdawar and Village secretary in presence of Duty Magistrate, Aruna Kumari, Naib Tehsildar, Palhawas. The possession of encroached land so vacated has been delivered to Vijay & Omprakash, Gram Sachivs against proper receipt Annexure-R3.

4. That the encroachment of petitioner from Khasra No. 254 Min has been removed and possession has been delivered to Panchayat Department hence the order dated 18.05.2022 complied in its complete letter and spirits.”

Counsel for the petitioner also states that the area which has been found to have been encroached upon by the petitioner, has been vacated and handed over to the Gram Panchayat.

In the light of the above, the present writ petitioner stands disposed of.
