Petition was filed in the year 1998, *inter alia*, for issuance of a writ in the nature of Mandamus commanding the respondents to take back the petitioner in service forthwith and regularize him as Beldar in view of the policy decisions issued by Government of Haryana.

2. Petition was admitted on 24.02.1998.

3. When called out for hearing, there is no representation on behalf of the petitioner. It seems that by sheer effluxion of time and pendency of the writ petition for more than 23 years before this Court, it has been rendered infructuous and the petitioner seems to have lost interest in pursuing the same.

4. In any case, it appears that even on merits, claim of the petitioner is not admissible in view of the following stand taken in the preliminary objection in the reply, which is reproduced herein for ready reference:-

“The Civil Writ Petition 2684 of 1998 deserves to be dismissed as the petitioner is not entitled for regularization of his services w.e.f. 31/1/96, as per the Govt. instruction dated 27/5/93, as he does not fulfil the conditions as required under the instructions/ policy of Haryana Govt. There was break in service of the petitioners for more

than 30 days at a stretch. A copies of the Muster Roll for the month of 3/93 & 4/93 is attached as Annexure R-1."

5. The above stand taken in the written statement remains uncontroverted since neither replication and/ or affidavit has been filed.

6. In the premise, petition stands dismissed.
