This petition is filed seeking directions for expeditious action on complaint No. 3490-PD dated 29.9.2021 filed by petitioner No.2.

Affidavit dated 10.5.2022 of Raj Kumar, PPS, Deputy Superintendent of Police, Sub-Division Tanda, District Hoshiarpur has been filed on behalf of respondent No.1 to 3 and the same is taken on record.

From the pleadings, it is forthcoming that petitioners were involved in two FIRs under Section 420 IPC. The allegations were that the petitioners had ostensibly received money from the complainant on the

pretext of sending the complainants abroad. In order to settle the issues with the complainant, petitioner No.1 sold her house to respondent No.-5 Veena Kumar-wife of respondent No.4. The house was resold by the respondent No.5 to petitioner No.1. Due to the differences regarding financial transactions, complaints were being filed against each other.

As per the affidavit filed, some of the complaints *inter se* parties have been filed, the others are being enquired into.

Considering the background of the complaints, it is not an appropriate case for this Court to exercise powers under Section 482 Cr.P.C, *in* moreso, when the statutory remedies under the Cr.P.C. are available.

Petition is dismissed

Needless to say that petitioners would be at liberty to avail remedies in accordance with law for redressal of surviving grievances, if any.

Learned counsel for the petitioner prays for similar liberty as given in **CRM-M-48817-2021**.

Petition is dismissed with liberty as prayed for.

Since the main cases have been decided, the pending application, if any, is disposed of as infructuous.
