This common order shall dispose of above noted three petitions
as they arise out of the same FIR.

Prayer in these petitions are for grant of anticipatory bail to petitioners in FIR No. 0101 dated 16.09.2019, registered under Sections 324, 341, 148, 149 of the IPC (Sections 326 and 307 of the IPC added later on) at Police Station Division No. 2, Jalandhar.

Learned State counsel submits that despite orders dated 13.05.2021 and 07.07.2021, petitioners Mohit alias Monu, Sajjan Kumar alias Kali alias Sajjan Patti and Aman have not joined investigation.

Learned State counsel further submits that petitioner Aman is involved in 07 more cases and petitioner Mohit alias Monu is also involved in another case.

As per allegations in the FIR, registered on the statement of complainant Manbir Singh, it is stated that he is working in a Pub (Bar) and when he was coming back to home at about 12.30 AM, 10-12 unidentified persons, armed with *Kirpan* and *Datar*, stopped him and started giving beatings. Thereafter, on 23.10.2019, the complainant suffered a supplementary statement stating that Satbir Sharma, Mohit, Karan Sehgal, Sajjan Patti and Aman were the accused persons and Satbir Sharma gave a datar blow which hit his nose, whereas accused Aman, Kannu, Kalli and Monu gave him injuries with baseball bat, iron rod and *sotas*, respectively.

Learned State counsel further submits that the complainant has suffered fracture of bilateral nasal bone, floor of both orbit and in right zygomatic bone and this injury has been declared dangerous to life. It is further submitted that since the petitioners have not joined investigation, recovery of weapons is yet to be effected.

Learned State counsel has further raised an objection that though petitioner Satbir Singh has joined investigation, however, he is the

main accused, who has caused fracture of nasal bone of the complainant and this injury was declared dangerous to life.

Learned State counsel has further submitted that though the petitioners were initially granted the concession of interim bail on the basis of the compromise, however, the petitioners have not adhered to the compromise.

Learned counsel for the petitioner(s) could not dispute the aforesaid facts.

After hearing learned counsel for the parties and considering the allegations against the petitioners as well as the fact that petitioners Mohit alias Monu and Sajan Kumar alias Kali alias Sajjan Patti did not join investigation despite being granted several opportunities, I find no ground to grant the concession of anticipatory bail to the petitioners.

Accordingly, the present petitions are dismissed.
