petitions as they are similar in nature.

The aforesaid petitions have been filed with the following
prayers:

1	TA-425-2021	Prayer in this petition is for transferring the Civil Suit bearing No. CS/851/2018 titled as <i>Suresh Kumar Singhal vs. Raj Kumar Singal</i> , pending before the Civil Judge (Sr. Divn.), SAS Nagar to the competent Court of jurisdiction at Chandigarh.
2	TA-427-2021	Prayer in this petition is for transferring the Civil Suit bearing No. CS/62/2019 titled as <i>M/s National Woollen Finishers and another vs. Indian Overseas Bank and another</i> , pending before the Civil Judge (Sr. Divn.), Panipat to the competent Court of jurisdiction at Chandigarh.
3	TA-428-2021	Prayer in this petition is for transferring the Civil Suit bearing No. CS/2165/2018 titled as <i>Suresh Kumar Singal vs. Raj Kumar Singal</i> , pending before the Civil Judge (Jr. Divn.), Panipat to the competent Court of jurisdiction at Chandigarh.
4	TA-429-2021	Prayer in this petition is for transferring the Civil Suit bearing No. CS/2241/2018 titled as <i>National Woollen and Finishers through Its Proprietor Suresh Kumar Singal vs. Raj Kumar Singal</i> , pending before the Civil Judge (Sr. Divn.), Panipat to the competent Court of jurisdiction at Chandigarh.

Learned counsel for the parties are *ad idem* that the dispute is
between the two real brothers and though the efforts were made before the
Mediation and Conciliation Centre of this Court for some amicable
settlement, however, no settlement could be arrived at between the parties.

Learned counsel, appearing for petitioner Raj Kumar Singal, submits that he has no objection if all the petitions are transferred to a competent Court of jurisdiction at Panipat, so that they may be decided together.

Learned counsel, appearing for respondent Suresh Kumar Singal, has no objection to the offer made by learned counsel for the petitioner as respondent-Suresh Kumar Singal himself is residing at Panipat.

In view of the consent given by learned counsel for the parties, these petitions are disposed of with a direction that the all the five Civil Suits, mentioned above, shall be transferred to a competent Court of jurisdiction at Panipat, along with all the records.

The District Judge, Panipat will assign all the five Civil Suits to one Court, so that the same may be decided together.
