**KARAMJIT SINGH, J. (Oral)**

Prayer in this petition is for quashing of GD No.24 dated 11.9.2016 under Sections 341, 323, 34 IPC in FIR No.89 dated 11.9.2016 registered under Sections 324, 323, 354-B, 34 IPC (Section 354-B IPC deleted) at Police Station Bhadson, District Patiala on the basis of compromise.

The above stated GD was registered on the statement of the complainant/respondent No.2-Jagjit Singh against the petitioners.

On notice of motion, respondents No.2 to 4 appeared in the Court through their counsel and pleaded that they have no objection if the FIR in this case is quashed on the basis of the aforesaid compromise which

has been effected between the parties.

During the course of preliminary hearing, the trial Court/Illaq Magistrate was directed to record the statements of the all the concerned parties with regard to genuineness and validity or otherwise of the aforesaid compromise.

In compliance thereof, report from the Court of Sub Divisional Judicial Magistrate, Nabha along with statements of the parties/their attorneys has been received, in which, it is mentioned that the compromise is genuine and there was no undue influence or coercion from any side.

I have heard learned counsel for the parties.

Learned counsel for the petitioner(s) and for respondents No.2 to 4 are *ad idem* that in view of the settlement effected between the parties, the present petition deserves to be accepted. It has also come on record that the aforesaid compromise is genuine and the parties effected the same without any undue influence or coercion.

In view of above, nothing remains to be adjudicated further in the present case. Thus, continuation of the criminal proceedings between the parties would be a futile exercise and sheer wastage of time of the Court and thus, amount to abuse of process of law.

For the reasons aforestated and having regard to the law laid down by Hon'ble Apex Court in **Gian Singh v. State of Punjab and another**, 2012 (4) RCR (Criminal) 543 and Five Judges Bench of this Court in **Kulwinder Singh and others v. State of Punjab and another**, 2007(3) RCR (Criminal) 1052, this petition is allowed and GD No. 24 dated 11.9.2016 under Sections 341, 323, 34 IPC in FIR No.89 dated 11.9.2016

deleted) at Police Station Bhadson, District Patiala and all the subsequent proceedings are hereby quashed qua the petitioners.
