The petitioner has filed the instant petition under Section 438 Cr.P.C. for grant of anticipatory bail in case bearing FIR No. 0187 dated 27.03.2022 registered under Section 21(b), 27-A of the Narcotic Drugs and Psychotropic Substances Act, 1985 registered at Police Station City Fatehabad, District Fatehabad.

Learned counsel for the petitioner *inter alia* contends that pursuant to the order dated 06.04.2022 passed by this Court, the petitioner has joined investigation and is no longer required for investigation of the case.

Learned State counsel on instruction from ASI Rameshwar Dass corroborates the said averment and submits that the custodial interrogation of the petitioner is not required for the purpose of investigation.

Heard learned counsel for the parties.

Since the petitioner has joined the investigation and his custodial interrogation is not required, the present petition is allowed and the interim order dated 06.04.2022 is made absolute.

However, the petitioner shall continue to join investigation as and when required to do so and shall abide by the terms and conditions, as laid down under Section 438 (2) Cr.P.C.
