The present petition was submitted by the petitioner-Rajesh through Jail at Bhiwani and submitted that he had been awarded sentenced by the District Courts in three different cases, which are as under:-

1. *FIR No.126 dated 03.09.2005 under Section 307, Police Station Bawani Khera (Bhiwani) in Criminal Appeal No.1616-SB-2007, Imprisonment – 10 years.*
2. *FIR No.122 dated 16.09.2004 under Sections 363, 376 of IPC, Police Station Bawani Khera (Bhiwani) in Criminal Appeal No.1330-SB-2007, period of imprisonment– 7 years.*
3. *FIR No. 10 dated 16.01.2006, under Section 392/394 of IPC and 25/54/59 of Arms Act, P.S. GRP, Rohtak in Appeal No.194-SB-2008, Sentence – 7 years.*

Today, the learned State counsel has filed the custody certificate and as per the said custody certificate, the petitioner/appellant has undergone the sentence of imprisonment in the following two cases:-

- (1) *FIR No.126 dated 03.09.2005 under Section 307 of IPC and Section 25 of Arms Act, Police Station Bawani Kheri (Bhiwani) in Criminal Appeal No.1616-SB-2007, the appellant has already undergone 10 years of total sentence including remission.*
- (2) *FIR No.122 dated 16.09.2004 under Sections 363, 376 of IPC, Police Station Bawani Kheri (Bhiwani) in Criminal Appeal No.1330-SB-2007, the appellant has already undergone 07 years of total sentence including remission.*

Ultimately, the appellant is facing the prosecution only in FIR No. 10, dated 16.01.2006, under Section 392/394 of IPC and 25/54/59 of Arms Act, P.S.GRP, Rohtak and has already preferred Criminal Appeal No.194-SB-2008, which is pending before this Court.

Since only one appeal is pending for disposal, there is no need for passing further orders and the instant petition has been rendered infructuous.
