Learned counsel for the petitioner states that he be permitted to withdraw the present petition. However, he has prayed that a direction be issued to the trial Court to complete the trial in an expeditious manner.

Of course expeditious trial is right of every litigant. Nevertheless, while allowing the request of counsel for the petitioner seeking withdrawal of the present petition, the trial Court is directed to make earnest efforts to conclude the trial expeditiously by giving short adjournments, refusing to grant adjournment except for justifiable reasons, which are to be recorded in the order. The State shall cause appearance of the remaining prosecution witnesses on each date so fixed.

Of course, no unnecessary adjournment would be asked on behalf of the accused, if trial is to proceed expeditiously. The necessary exercise be completed preferably within a period of 06 months from the date of receipt of copy of order there.

The present petition is dismissed as withdrawn.

Copy of the order be sent to the trial Court for necessary compliance.
