the Tribunal is allowed to the claimants-respondent Nos.1 to 4 in full and
final settlement of the claim in this appeal. As per the statement of learned
counsel for the claimants-respondent Nos.1 to 4, the enhanced amount be

paid to respondent No.1 – Smt.Kamlesh wife of Shri Balraj.

Accordingly, we dispose of this case with a direction to the Insurance Company to deposit a crossed-cheque for ₹2,25,000/- in the name of respondent No.1 – Smt.Kamlesh wife of Shri Balraj with the office of the Lok Adalat of the High Court within 45 days, in compliance of this order, failing which, interest @ 9% per annum shall follow on this amount till payment from the date of this order. The concerned Officer of the Lok Adalat Branch/Office shall issue proper receipt after receiving the cheque to learned counsel/representative of the Insurance Company. The respondent (s)' counsel/respondent(s) may collect the cheque from the office of the Lok Adalat.

Copy of the order be supplied/sent to the counsel/parties and file be returned to the Hon'ble High Court.
