The petitioners namely Jagdeep Kaur and Harmanjit Singh have approached this Court under Article 226 of the Constitution of India read with Section 482 Cr.P.C. for seeking protection of their life and personal liberty from private respondents No.4 to 6.

The contention of the petitioners is that both are major, aged 26 years and 34 years respectively. In support thereof, copy of Passport pertaining to petitioner No.1(Annexure P-1) and copy of Aadhaar Card pertaining to petitioner No.2(Annexure P-2) have been appended. The petitioners further contend that they have performed marriage against the wishes of their parents. The marriage of the petitioners was solemnized on 12.04.2022 at Gurudwara Dashmesh Pita Patshahi Dasvi (Regd.), Village Singha Devi, Tehsil Kharar, District Mohali according to Sikh rites and

ceremonies. A copy of marriage certificate (Annexure P-3) issued by the aforesaid Society has also been appended. The petitioners apprehend threat to their lives and claim that there is a constant danger of being implicated in a false case.

Notice of motion restricted to respondents No.1 to 3 only.

Pursuant to supply of advance copy, Ms. A.K. Khurana, D.A.G., Punjab, has appeared and accepted notice on behalf of respondents No.1 to 3.

Learned counsel for the petitioners states that a representation dated 18.04.2022 (Annexure P-4) has also been submitted by the petitioners to the respondent No.2-Senior Superintendent of Police, Jagraon, District Ludhiana.

Learned State counsel has no objection if appropriate direction for providing requisite protection to the petitioners is given.

Without examining the question of legality and validity of the marriage and expressing any opinion thereon, the present petition is disposed of with the directions to respondent No. 2 - Senior Superintendent of Police, Jagraon, District Ludhiana to look into the grievances of the petitioners as set out in the petition and also expressed in the representation (Annexure P-4) and take appropriate action for protection of their lives and liberty as may be warranted by the circumstances.

However, it is clarified that in case any criminal case has been/is registered against the petitioners nothing in this order shall be construed as a bar for taking appropriate action by the police authorities in respect thereof in accordance with law.

The Registry is directed to send a copy of this order along with

copy of the petition and above-said representation to respondent No.2-
Senior Superintendent of Police, Jagraon, District Ludhiana for requisite
compliance.

The petition is disposed of.
