The petitioners namely Preeti Manan and Gurinder Singh have approached this Court under Articles 226/227 of the Constitution of India for seeking protection of their life and personal liberty from private respondents No.4 to 6.

The contention of the petitioners is that both are major, aged 29 years and 28 years respectively. In support thereof, copy of Passport pertaining to the petitioner No.1(Annexure P-1) and copy of Aadhaar Card pertaining to the petitioner No.2(Annexure P-2) have been appended. The petitioners further contend that they have performed marriage against the wishes of their parents. The marriage of the petitioners was solemnized on 25.04.2022 at Gurudwara Sadh Sangat Parbandhak Committee (Regd.), Kot Baba Deep Singh, Street No.7, Amritsar according to Sikh rites and ceremonies. A copy of marriage certificate (Annexure P-3) issued by the aforesaid Society has also been appended. The petitioners apprehend threat

to their lives and claim that there is a constant danger of being implicated in a false case.

Notice of motion restricted to respondents No.1 to 3 only.

Pursuant to supply of advance copy, Ms. A.K. Khurana, D.A.G., Punjab, has appeared and accepted notice on behalf of respondents No.1 to 3.

Learned counsel for the petitioners states that a representation dated 25.04.2022 (Annexure P-4) has also been submitted by the petitioners to the respondent No.2-Senior Superintendent of Police, District Amritsar.

Learned State counsel has no objection if appropriate direction for providing requisite protection to the petitioners is given.

Without examining the question of legality and validity of the marriage and expressing any opinion thereon, the present petition is disposed of with the directions to respondent No. 2 – Commissioner of Police, District Amritsar/Senior Superintendent of Police, District Amritsar to look into the grievances of the petitioners as set out in the petition and also expressed in the representation (Annexure P-4) and take appropriate action for protection of their lives and liberty as may be warranted by the circumstances.

However, it is clarified that in case any criminal case has been/is registered against the petitioners nothing in this order shall be construed as a bar for taking appropriate action by the police authorities in respect thereof in accordance with law.

The Registry is directed to send a copy of this order along with copy of the petition and above-said representation to the Commissioner of Police, District Amritsar/Senior Superintendent of Police, District Amritsar for requisite compliance.

The petition is disposed of.
