This is petitioner's third attempt to get bail pending trial in a criminal case arising from FIR No. 102 dated 03.07.2019 registered under Sections 406, 420 of the Indian Penal Code at Police Station Adampur, District Jalandhar (Rural).

The first petition for grant of bail was dismissed on 16.10.2019, with the following order:-

“Petitioner prays for grant of regular bail in FIR No.102 dated 03.07.2019 registered under Sections 420/406 of the Indian Penal Code at Police Station Adampur, Jalandhar.

As per the allegations, petitioner, a married girl residing in Canada, is duping unemployed youth of Punjab by entering into marriage alliance while promising them immigration to Canada.

As per the status report filed, the petitioner is a habitual offender involved in as many as 9 such cases. Details of the cases as provided in the status report are extracted as under:-

In this case also, the petitioner initially entered into a settlement and agreed to repay the amount. However, out of Rs.7,00,000/- extracted from the first informant, only Rs.3,00,000/- was paid. Now, the counsel submits that the aforesaid settlement is under pressure.

Keeping in view the aforesaid facts and series of the cases against the petitioner, this Court is not inclined to grant concession of bail to the petitioner.

Accordingly, the present petition is dismissed.”

The second petition was dismissed on 06.03.2020.

Keeping in view the facts noticed in the order dated 16.10.2019, no fresh ground to grant bail to the petitioner is made out.

Hence, dismissed.

All the pending miscellaneous applications, if any, are also disposed of.
