VIKAS BAHL, J. (ORAL)

This is a petition filed under Section 482 Cr.P.C. for quashing of DDR No.28 dated 12.10.2021 registered under Sections 323, 324, 341, 506, 148, 149 of the Indian Penal Code, 1860 at Police Station Division No.7, Ludhiana (Annexure P-2) in FIR No.191 dated 10.10.2021 registered under Sections 323, 341, 506, 148, 149 of IPC at Police Station Division No.7, District Ludhiana and all the subsequent proceedings arising therefrom on the basis of compromise.

On 07.05.2022, this Court had passed the following order:-

“This is a petition filed under Section 482 Cr.P.C. for quashing of DDR No.28 dated 12.10.2021 registered under Sections 323, 324, 341, 506, 148, 149 of the Indian Penal Code, 1860 at Police Station Division No.7, Ludhiana (Annexure P-2) in FIR No.191 dated 10.10.2021 registered under Sections 323, 341, 506, 148, 149 of IPC at Police

Station Division No.7, District Ludhiana and all the subsequent proceedings arising therefrom on the basis of compromise.

Learned counsel for the petitioners has submitted that all the persons concerned are party to the compromise.

Notice of motion for 24.05.2022.

On asking of the Court, Mr. Sarabjit S. Cheema, AAG, Punjab appears and accepts notice on behalf of the respondent-State and Ms. M.D. Koonj, Advocate for Mr. Deepak Arora, Advocate appears on behalf of respondent Nos.2 to 7.

The parties are directed to appear before the Illaqa Magistrate/trial Court for recording their statements qua compromise within a period of 10 days.

The Illaqa Magistrate/trial Court is directed to submit a report on or before the next date of hearing containing the following information:-

- 1. Number of persons arrayed as accused.*
- 2. Whether any accused is proclaimed offender?*
- 3. Whether the compromise is genuine, voluntary and without any coercion or undue influence?*
- 4. Whether the accused persons are involved in any other FIR or not?*
- 5. The trial Court is also directed to record the statement of the Investigating Officer as to how many victims/complainants are there in the FIR.*

To be heard alongwith CRM-M-18326-2022.”

In pursuance of the abovesaid order, a report has been submitted by the Judicial Magistrate Ist Class, Ludhiana. The relevant portion of the said report is reproduced hereinbelow:-

“The report is submitted as under:

- 1. The number of accused persons arrayed in the present*

DDR are eight namely Bapu Manohar Ingole @ Rangu, Anna Ingole @ Anil Ingole, Chhaya Manohar Ingole @ Chhaya, Gita Ramchandra Bhosale @ Geeta @ Rekha, Kishore Suresh Ingole @ Kishore @ Golu, Rahul Shiva Bosle, Anand Shiva Bhosle and Santosh Devanand, who are the petitioners in the present CRM-M. All eight accused persons appeared in the Court and made statements with regard to compromise with the complainants/respondents.

2. As per the report of the IO as well as of the Ahlmad, no proclamation proceedings was ever issued in the present case.

3. After perusing the statements of the concerned parties, this Court is satisfied that the compromise arrived at between them is genuine, voluntary and without any coercion or undue influence.

4. As per the statement of the IO, the accused persons are not involved in any other case.

5. As per the statement of the IO, there is one complainant i.e. Aneeta and two victims namely Machinder and Vicky in the present case and they appeared before the Court and made their statement in support of compromise.

Hence, the report is submitted.

A perusal of the said report would show that the compromise has been found to be genuine, without any pressure or undue influence. It has been stated that the statements of the complainant as well as the accused

have been recorded in the case and both have stated that the matter has been compromised and they have no objection in case the FIR is quashed. It is further stated that the statement of the complainant has been made voluntarily without any fear, coercion or pressure.

A perusal of clause 5 of the above report would also show that there is one complainant and two victims which has been wrongly mentioned. In fact, there is one complainant and five victims i.e. a total of 6 complainants/victims, which is clear from the joint statement of the said six victims/complainant confirming the factum of compromise. The joint statement of the said six victims/complainants is attached alongwith the abovesaid report and the same is also reproduced here under:-

- 6. Vicky Bhosle S/o Ashok @ Ashu Bhosle, R/o House No. 3250, EWS Colony, Tajpur Road, Ludhiana.*

On S.A.

Stated that a cross DDR No. 28 dt. 12.10.2021 under Sections 323/324/341/506/148/149 IPC in FIR No. 191 dt. 10.10.2021 registered under Sections 323/341/506/148/149 IPC, P.S. Division No. 7, Ludhiana at the statement of complainant Aneeta. The matter in dispute regarding the said case has been compromised vide compromised deed Ex. C1 (copy placed on record) with the accused persons namely Bapu Manohar Ingole @Rangu, Anna Ingole @ Anil Ingole, Chhaya Manohar Ingole @ Chhaya, Gita Ramchandra Bhosale @ Geeta, Kishore Suresh Ingole @ Kishore @ Golu, Rahul Shiva Bhosle, Anand Shiva Bhosle, Santosh Devanand Ingole with our free will and without any coercion or undue influence from the accused side. One quashing petition has been filed in the Hon'ble High Court i.e. CRM-M-19033-2022 titled as "Bapu Manohar Ingole @ Rangu & others State of Punjab & others." and in compliance of the order dt. 07.05.2022, we have got our statement recorded today in the Court. We have no objection if the present FIR is quashed.

Learned counsel for the petitioners has submitted that the petitioners were not declared proclaimed offender in the present case and there are no other cases pending against the petitioners. Learned counsel for the State, as per instructions has stated that these facts are correct.

Learned counsel for respondent Nos.2 to 7 has again reiterated that the matter has been settled and the said compromise is in the interest of all the persons and would help in bringing out peace and amity between the two parties.

This Court has heard the learned counsel for the parties and has perused the file. After perusing the report submitted by the trial Court, this Court finds that the matter has been amicably settled between the petitioner and the complainant. Since the matter has been settled and the parties have decided to live in peace, this Court feels that in order to secure the ends of justice, the criminal proceedings deserve to be quashed.

As per the Full Bench judgment of this Court in “**Kulwinder Singh and others Vs State of Punjab**”, reported as **2007 (3) RCR (Criminal) 1052**, it is held that High Court has power under Section 482 Cr.P.C. to allow the compounding of non-compoundable offence and quash the prosecution where the High Court is of the opinion that the same is required to prevent the abuse of the process of law or otherwise to secure the ends of justice. This power of quashing is not confined to matrimonial disputes alone.

Hon'ble the Apex Court in the case of “**Gian Singh Vs. State of Punjab and another**”, reported as **2012 (4) RCR (Criminal) 543**, had also observed that in order to secure the ends of justice or to prevent the abuse of process of Court, inherent power can be used by this Court to quash criminal proceedings in which a compromise has been effected. The relevant portion of para 57 of the said judgment is reproduced hereinbelow:-

“57. The position that emerges from the above discussion can be summarised thus: the power of the High Court in quashing a criminal proceeding or FIR or complaint in exercise of its inherent jurisdiction is distinct and different from the power given to a criminal court for compounding the offences under Section 320 of the Code. Inherent power

is of wide plenitude with no statutory limitation but it has to be exercised in accord with the guideline engrafted in such power viz; (i) to secure the ends of justice or (ii) to prevent abuse of the process of any Court. XXX---XXX”

In view of what has been discussed hereinabove, the petition is allowed and DDR No.28 dated 12.10.2021 registered under Sections 323, 324, 341, 506, 148, 149 of the Indian Penal Code, 1860 at Police Station Division No.7, Ludhiana (Annexure P-2) in FIR No.191 dated 10.10.2021 registered under Sections 323, 341, 506, 148, 149 of IPC at Police Station Division No.7, District Ludhiana and all the subsequent proceedings arising therefrom on the basis of compromise, are ordered to be quashed, qua the petitioners.

All the pending miscellaneous applications, if any, stand disposed of in view of the abovesaid judgment.
