The prayer in the present petition under Section 482 Cr.PC is for issuance of direction for a free, fair, impartial and proper investigation in case FIR No.608 dated 21.07.2016 registered at P.S. Sadar Karnal, District Karnal under Sections 302/34 IPC to be conducted by some independent agency/CBI or for directions to be issued for the investigation to be supervised by Senior Superintendent of Police.

On 25.04.2022 the following order was passed:-

“ Vide order dated 19.02.2018, the Superintendent of Police, Karnal was directed to personally look into the matter and give a specific reply with regard to the allegations levelled by the petitioner and whether they have been duly dealt with

properly in the investigation or not and whether he is satisfied with the investigation or not.

On 19.03.2018, a reply was filed by the learned State counsel by way of an affidavit of Superintendent of Police, Karnal on behalf of respondent Nos.1 to 4.

A perusal of the reply would show that a cancellation report was submitted before the Illaqa Magistrate, Karnal on 26.09.2017 and the S.H.O., Karnal was directed to appear before the concerned Court and obtain the file for further investigation.

In view of the above, a fresh reply is required to be submitted by the Superintendent of Police, Karnal as to the current status of the investigation.

The learned State counsel seeks time to file fresh status report.

To come up on 26.07.2022.

In furtherance of the aforesaid order, the Status report by way of affidavit of Mr. Ganga Ram Punia, IPS, Superintendent of Police, Karnal has been filed on behalf of the respondent dated 22.07.222. As per the said reply vide order dated 5.3.2018 the further investigation of this case was ordered. Further investigation was conducted by SHO Sadar, Karnal, who got conducted the Polygraph Test of Surinder and nothing suspicious was found against him. The Polygraph test report dated 4.4.2018 is attached with the Status report as Annexure R-1. It has been concluded during the investigation that the deceased Krishna was making preparation for bathing in the bathroom. An electric extension board was kept upon the wash basin which led to her electrocution. In fact accused Surinder had entered into the bathroom by breaking the window from outside. Therefore, the role of the accused could not be substantiated during the course of investigation.

In view of the aforementioned facts ascertained during the

course of investigation, a cancellation report has been prepared and submitted in the court of ACJM, Karnal on 12.07.2022. The petitioner would have his right to challenge the same by way of a protest petition.

In view of the above, no further orders are required to be passed i the present petition.
