These are the applications for placing on record copy of the compromise dated 20.01.2021 as Annexure A-1 in all the appeals and also for disposing off the main appeals on the basis of the said compromise.

For the reasons stated in the applications, the same are allowed. Copy of the compromise dated 20.01.2021 is taken on record as Annexure A-1 in all the appeals.

Main Appeals

By this common order, the above-captioned 08 Regular Second Appeals are being disposed off. These appeals arise out of a dispute between three parties, namely, Avtar Singh, Jaspal Singh and Charan Kaur on one hand; Manjit Kaur and Harpreet Kaur on the second hand; and Karamjeet Singh, Ranjit Singh, Simranjeet Singh, Balwinder Kaur, Rajwant Kaur and Parminder Kaur on the third hand.

The dispute pertains to the estate of Tara Singh. During the pendency of these appeals the parties to the *lis* have arrived at a compromise dated 20.01.2021 which has been reduced into writing. Vide order dated 19.04.2021 this Court had directed that the statements of the parties be recorded before the Mediation and Conciliation Centre of this Court. Report of the Mediator has since been received as per which joint statements of the parties have been recorded wherein they all have stated that they have voluntarily entered into a compromise and the dispute between them now

stands settled. They have also admitted their respective signatures/thumb impressions on the compromise.

Learned counsel for the parties are *ad idem* that all the disputes between the parties stand resolved and pray that these appeals may be disposed off in terms of the compromise, which has been appended as Annexure A-1 in all the appeals.

In view of the statements of the parties recorded before the Mediator as well as statements made by learned counsel for the parties, all the above-captioned appeals are disposed off in terms of the compromise dated 20.01.2021 (Annexure A-1) which is exhibited as C-1 and is made part of the decree. Registry to draw the decree sheet accordingly.

Pending applications, if any, also stand disposed off.
