Prayer in the present petition is for grant of anticipatory bail to the petitioner in FIR No.32 dated 03.04.2022 registered under Sections 307, 323, 324, 326, 148 and 149 of the Indian Penal Code, 1860 at Police Station Jalandhar Cantt., District Jalandhar, Punjab.

After arguing for sometime and after seeing that this Court is not inclined to interfere in the matter, learned counsel for the petitioner seeks permission of this Court to withdraw the present petition and states that the petitioner is ready to surrender before the police within a period of 7 days from today.

Learned counsel for the petitioner has further made a prayer that in case, the petitioner surrenders before the police within a period of 7

days from today and files an application for grant of regular bail after surrender, the same be decided as expeditiously as possible preferably within a period of five days from the date of filing of the said application.

In view of the statement made by learned counsel for the petitioner, the present petition is dismissed as withdrawn.

The petitioner is directed to surrender before the police within a period of 7 days from today.

In case, after surrendering before the police within a period of 7 days from today, the petitioner files an application for grant of regular bail, the trial Court is requested to decide the same as expeditiously as possible preferably within a period of five days from the date of filing of the said application.
