The present petition has been filed by Paramjeet Singh for grant of anticipatory bail in case FIR No.0063 dated 30.03.2022, registered under Sections 323, 324, 148, 149, 452 and 326 IPC at Police Station Lambi, District Sri Muktsar Sahib.

As per the allegations of complainant Jaswant Singh, on account of a Court order in his favour dated 26.03.2022, demarcation had been done of the land in possession of Gurmeet Kaur, wife of the present petitioner, who has filed separate CRM-M No.26296 of 2022.

It is the allegation that both husband and wife along with other persons entered the Flour Mill of the complainant and inflicted injuries on the complainant and Iqbal Singh. The allegation against the present petitioner is that with the Kirch, he had attacked neck of the complainant and his lady-finger was injured in the process of defending the blow. Another blow was also given on his left arm. Iqbal Singh, who tried to rescue the complainant, was also attacked by the accused along with Gurjeet Singh and he also suffered injuries. Perusal of MLRs of complainant Jaswant Singh and Iqbal Singh, produced by HC Palwinder Singh, would go on to show that they both received grievous injuries, which are reproduced as under:-

Injury on the person of complainant Jaswant Singh

“Incised wound 4 cm x 0.5 cm on middle phalanx of little fingers of left hand x-ray left hand ortho opinion. AS PER ORTHO OPINION ON MLX 48 BY ORTHO PAEDITION

CRM-M No.26293 of 2022

CIVIL HOSPITAL GIDDERBAHA ON 31.03.2022 THERE IS UNICORTICAL FRACTURE OF MIDDLE PHALANX OF LITTLE FINGER AS PER ORTHO OPINION INJURY NO.2 IS GREVIOUS IN NATURE.”

Injury on the person of Iqbal Singh

“ INCISED WOUND OVER RIGHT HAND OVER BACK OF HAND AND INDURATION OF ENTIRE HAND (X-RAY RIGHT HAND) (ORTHO OPINION)
AS PER ORTHO OPINION ON MLX 47 BY ORTHO PAEDITION CIVIL HOSPITAL GIDDERBAHA ON 31.03.2022 THERE IS FRACTURE 4TH METCARPAL OF RIGHT HAND INJURY NO.4 IS GREVIOUS IN NATURE.”

In such circumstances, this Court is of the considered opinion that denial order of anticipatory bail by the Court below, on the ground that there were 8 injuries on the person of the complainant and 6 injuries on the person of Iqbal Singh, does not suffer from any infirmity or illegality for the grant of concession of anticipatory bail by this court.

Accordingly, the present petition is hereby dismissed.
