The instant petition has been filed under Article 226 of the Constitution of India for issuance of order or directions to the official respondents no.2 and 3 for protection of life and liberty of the petitioners and not to interfere in the peaceful life of the petitioners at the behest of respondents No. 4 to 9.

A perusal of the office report shows that notice could not be issued to respondents No.4 to 9 for want of process fee.

A copy of status report by way of affidavit of Karan Goel, Additional S.P. Kurukshetra has been handed over in the Court by the learned State Counsel. The relevant extract thereof reads as under:-

“The answering deponent immediately directed in-charge  
*police post City, Shahabad to comply the order of this  
Hon’ble Court. In response to this incharge police post  
City, Shahabad recorded the statements of Respondent*

*No.4 Sarvjit Singh (the father of petitioner No.1), Statement of Satinder Kaur Respondent No.5, (mother of petitioner No.1), Amanjit Singh respondent No.6, (Uncle of petitioner No.1) etc were recorded, in which they have alleged that on 23.06.2022 Simran Sodhi solemnized marriage with Lovepreet Singh and they have no objection qua this marriage and we or any member of our family or any of our relatives will not cause any danger in the life of both of them nor will damage the property of both of them. The copy of same are attached as **Annexure R-1 to R-III** for the kind perusal of this Hon'ble Court.*

*3. That on 28.06.2022 the statement of petitioner No.1 was also recorded in which she has alleged that on 23.6.2022 I and Lovepreet Singh solemnized marriage in Gurudwara Dashmesh Patshahi 10<sup>th</sup>, Tehsil Khard, District Patiala, Punjab. Due to indanger of our life we kept in safehouse police Line, Kurukshetra.*

*At present I and Lovepreet have no threat from my relative as well as my family members and she further stated that she wants to live with Lovepreet singh R/o Majri Mohalla, Shahabad. At present she is residing with Lovepreet Singh. It is further submitted that the statement of petitioner No.2 was also record. However, the copy of the same are attached as **Annexure R-IV to R-V** for kind perusal of this Hon'ble Court."*

However, taking into consideration the averments contained in the Status Report as also the statements of the petitioner as well as the respondents appended, no further directions are required to be issued in the matter.

Disposed of as having been rendered infructuous.
