Present is an application, which has been preferred by the
respondent praying for vacation of the stay order granted by this Court on
04.07.2022 in an appeal which has been preferred by the
non-applicants/appellants challenging the order dated 18.02.2022 passed
by the learned Single Judge.

Notice of the application.

On the asking of the Court, Mr. Parvinder Chauhan,
Senior Additional Advocate General, Haryana, accepts notice on behalf
of the appellants.

Counsel for the parties have made a joint request that instead
of deciding the present application, the appeal itself may be taken up by

preponing the same from 27.07.2022.

Prayer made by the counsel for the parties is accepted and the appeal itself is taken up for consideration.

LPA No.526 of 2022

Parties have agreed that some time may be granted to the appellants to file reply to the writ petition and thereafter the main case may be posted before the learned Single Judge for decision.

Prayer made by the counsel for the parties is accepted.

One week's time from today is granted to the appellants, who are respondents in the writ petition to file reply to the writ petition.

Replication, if any, be filed by the respondent/petitioner within a period of two days thereafter.

Keeping in view the issue involved in this case which is of urgent nature as has been pointed out and agreed by the counsel for the parties, we would request the learned Single Judge to consider disposal of the writ petition at the earliest.

Counsel for the parties have requested that the matter may be listed on 02.08.2022.

Ordered accordingly.

Interim order as has been passed by this Court on 04.07.2022 shall continue till the decision of the writ petition.

It is made clear that no adjournment will be granted to the appellants/respondents in the writ petition as the counsel for the respondents has stated that the respondents would not take any.

The appeal stands disposed of accordingly.

Since the main case stands disposed of, no order is required to be passed in the pending applications and the same also stand disposed of.
