The instant petition has been filed under Section 482 Cr.P.C. for quashing of FIR No. 105 dated 19.06.2015 under Sections 498-A, 406, 323 and 34 of IPC registered at Police Station City Mona, District Moga (Annexure P-1) alongwith all consequential proceedings arising therefrom on the basis of compromise dated 12.07.2021(Annexure P-2).

Vide order dated 17.08.2021, while issuing notice of motion, a Co-ordinate Bench of this Court had directed the parties to appear before the Illaqa Magistrate/trial Court for getting their statements recorded with respect to the compromise dated 12.07.2021 (Annexure P-2).

Pursuant to aforesaid order, the parties have appeared before the learned Judicial Magistrate 1st Class, Moga and got their statements recorded. Report dated 08.10.2021 has been received whereby after

satisfaction that the compromise is genuine and voluntary. It has been further intimated that no PO proceedings are pending against any of the party.

I have heard counsel for the parties and gone through the case file.

In the light of the satisfaction shown by the Court below and considering the offence for which the accused have been charged, are not of serious nature, together with the fact that compromise will go a long way in ironing out the differences for betterment of future life of the parties and also in view of the law laid down in **Gian Singh Vs. State of Punjab and another, 2012 (4) RCR (Criminal) 543** and **Kulwinder Singh and others Vs. State of Punjab 2007(3) RCR (Criminal) 1052**, the present petition for quashing the FIR is allowed qua the petitioners.

Resultantly, FIR No. 105 dated 19.06.2015 under Sections 498-A, 406, 323 and 34 of IPC registered at Police Station City Mona, District Moga (Annexure P-1) alongwith all consequential proceedings arising therefrom on the basis of compromise dated 12.07.2021 (Annexure P-2) are hereby quashed qua the petitioners.
