Application is allowed, as prayed for.

CWP-15035-2022

Prayer in the instant civil writ petition filed under Articles 226/227 of the Constitution of India, 1950 is for issuance of a writ in the nature of mandamus directing the respondents to release the due amount qua the works executed by the petitioner at Aam Khas Bagh, Phase-I, Fatehgarh Sahib.

Briefly, the facts of the present petition are that the petitioner is a registered company in the name of M/s Rajputana Constructions (P) Ltd. The respondent No.2-Punjab Heritage and Tourism Promotion Board invited tenders for procurement of certain works at Aam Khas Bagh, Phase-I,

Fatehgarh Sahib and petitioner's bid was accepted. A contract agreement was executed between the parties and the agreement prescribed the date of work as 25.07.2015 and date of completion of the work as 24.01.2017. The assigned work was however duly completed and the petitioner submitted final bill amounting to ₹33,15,903.65 plus ₹10,34,948.70. The petitioner has been making oral as well as written request to the respondents for making payment of the aforesaid amount but the same has not been released.

Learned counsel appearing on behalf of the petitioner contends that at this stage he would be satisfied, in case, the present petition be treated as his representation and respondent no.3 is directed to decide the same by passing a speaking order in accordance with law.

Notice of motion.

Ms. Niharika Sharma, A.A.G., Punjab, who is present in Court and would be deemed to be on the panel of all statutory Boards and Corporations of the State of Punjab by virtue of her appointment is requested to accept notice on behalf of respondent No.1-State.

On the asking of the Court, Mr. Saurav Verma, Addl. A.G., Punjab, accepts notice on behalf of respondent Nos.2 and 3. They have no objection to the above prayer being allowed.

Accordingly, without commenting on the merits of the case and with the consent of the parties, the present civil writ petition is disposed of with a direction to respondent No.3-The Project Manager, Infrastructure Development Investment Programme for Tourism, Ropar to treat the present writ petition as a representation and to pass a speaking and reasoned order in accordance with law, preferably within a period of three months from the date of receipt of a certified copy of this order after granting an opportunity

of hearing to the respective parties.

If the entitlement of the petitioner is established upon consideration of the claim and verification of the record, then the payment be released to him within a further period of three months thereafter.

Petition is disposed of.
