The present petition has been filed under Section 439 Cr.P.C seeking the benefit of regular bail to the petitioner in case FIR No.0063 dated 23.3.2021 under sections 354-A, 354-B, 354-C, 506, 120-B I.P.C registered at Police Station, Jamalpur, District Ludhiana.

Succinctly the facts of the case are that the prosecutrix lodged the present FIR, wherein it was alleged that Inder Kumar son of Ram Chander Yadav was residing at the given address for the last 8 years. He used to help her father in their shop. On 1.11.2020 in the morning she went to bathroom to take bath and at that time her father and Inder Kumar were arranging goods in the boxes of the shop. Taking benefit of the situation Inder Kumar videographed her from his mobile phone when she was taking bath. Thereafter, Inder Kumar showed her bathing video on his mobile phone and she got afraid. It was further alleged that Inder Kumar sent the alleged video to his friend Deepak i.e. the present petitioner. Inder Kumar started exploiting her and finally the prosecutrix had no other option than to

report the matter to the police. Consequently, the present FIR was lodged.

The investigation commenced and petitioner Deepak Kumar Yadav was arrested on 14.6.2021. He approached learned Addl. Sessions Judge, Ludhiana for the grant of bail but the same was declined vide order dated 14.7.2022. Aggrieved by the same, petitioner has approached this Court for grant of bail.

Learned counsel for the petitioner vehemently contends that the petitioner was falsely implicated in the present FIR and the very fact that no offence under the I.T Act is added in the FIR would show that the allegations are false and frivolous. He submits that the only allegation against the present petitioner is that main accused Inder Kumar had sent obscene photographs of the prosecutrix to the present petitioner. Counsel submits that the investigation is complete and the challan has been presented, however, there is no recovery of any video as alleged in the FIR. Counsel submits that the prosecutrix already stands examined before the Trial Court and thus there cannot be any alleged apprehension against the petitioner for interfering in the ongoing trial. He submits that in total there are three accused out of which two have already been granted the benefit of bail including the main accused Inder Kumar. Counsel prays that further incarceration of the petitioner is unwarranted and he deserves to be enlarged on bail.

On the other hand, learned State counsel submits that there are specific allegations against the petitioner. He further submits that out of the 11 prosecution witnesses 2 including the complainant/prosecutrix have been examined by the Trial Court.

I have heard learned counsel for the parties at length and have gone through the records made available.

Petitioner is behind bars since 14.6.2021. Investigation is complete and the learned Trial Court is seized of the matter. Statements of prosecution witnesses are being recorded and admittedly prosecutrix already stands examined. In total there are three accused out of which two have already been granted the benefit of bail by this court including the main accused Inder Kumar.

In view of the peculiar facts and circumstances, I find that the veracity of the allegations levelled in the FIR would be established only after conclusion of the trial. In the totality of circumstances and without making any observations on merits, present petition is allowed. Petitioner be enlarged on bail subject to satisfaction of Trial Court/Duty Magistrate, concerned. Nothing stated herein shall be treated as an expression on the merits of the case.
