RAVI SHANKER JHA, CHIEF JUSTICE (Oral):

Both petitions have been filed by way of public interest litigation praying for a direction to the respondents to follow the policy guidelines dated 13.08.2008, in letter and spirit, thereby ensuring implementation of the terms and conditions as contained therein regarding free treatment to the poor persons or patients and making it mandatory for the hospitals to maintain record and registers thereof.

Respondents-hospitals have filed a compliance/status report

CWP Nos.14055 of 2015 and 9730 of 2016

indicating that they are duly following the policy guidelines (ibid). This Court had asked HUDA now HSVP to ensure further monitoring of the same and file an affidavit in that regard. An affidavit has not been filed by the HUDA now HSVP. However, while looking at the status report, filed by the private hospitals, the petition(s) which was filed by the petitioner(s) way back in 2015-2016, has out lived its utility and is accordingly dismissed, granting liberty to the petitioner(s) to approach the authorities, in case, any further violation of the policy conditions is observed upon or is made by the respondents hospitals. It goes without saying that in case the petitioner(s) approach the respondents-authorities, bringing to the notice of such violation, the authorities shall look into the same and take action in accordance with law.
