By this order a bunch of 233 appeals, (details whereof are on
the foot of the order), shall stand disposed of.

There are various applications filed for seeking condonation of delay in filing the appeal. The learned counsel representing the State of Haryana contends that these appeals have been filed after the lead case was decided.

Per contra, the learned counsel representing the landowners contends that the State of Haryana has also filed appeals post the decision of the lead case in which the delay has been condoned. He submits that the landowners should not be discriminated.

It is not in dispute that connected appeals filed by the State of Haryana are pending. Hence, the delay in filing the appeals is condoned, subject to the condition that the landowners shall not be entitled to the payment of interest, beyond the period of limitation from the final order passed by the Reference Court.

The learned counsel representing the parties are *ad idem* that all these appeals are referred by the decision of the High Court in **Regular First Appeal No.1817 of 2019, titled as “The Akash Cooperative Group Housing Society Ltd.-II Vs. State of Haryana and others”, decided on 27.05.2020.**

The learned State counsel has pointed out that in view of the orders dated 29.05.2020 and 10.08.2020 passed by the bench, the amount awarded has been corrected.

These appeals are disposed of in terms of final judgment passed by the High Court on 10.08.2020.

As per the office report, notices issued to certain respondents in various appeals have not been received back served or otherwise.

However, the unrepresented respondents shall have liberty to file an application for revival, if they want to address any further arguments.
