This order shall dispose of Civil Writ Petition Nos. 4966 and 18126 of 2019. Gram Panchayat, Gawalra, petitioners in CWP-18126-2019 and the petitioners in CWP-4966-2019 were aggrieved of the fact that despite passing of resolution dated 22.10.2018 by Gram Panchayat resolving to give 600 acres of land on lease during public auction on three different occasions alongwith consequent approval by the Government, vide order dated 29.10.2018, auction thereof was not conducted.

Learned counsel for the petitioners state that these writ petitions are rendered infructuous as auction proceedings have been carried out and concluded in February, 2020. Possession of the land given on lease was handed over to the concerned respective parties.

In view of the above, both the abovementioned writ petitions are disposed of as infructuous.
