The application is allowed.

The instant application has been filed under Section 151 of the Code of Civil Procedure, for placing on record press note dated 28.08.2022

(Annexure P-6) and election schedule dated 28.08.2022 (Annexure P-7).

The application is allowed.

Press note dated 28.08.2022 (Annexure P-6) and election schedule dated 28.08.2022 (Annexure P-7), are taken on record.

CM-12077-CWP-2022

The instant application has been filed seeking preponement of the date of hearing in the main case which is stated to be listed for hearing on 01.11.2022.

Learned counsel appearing on behalf of the petitioner contends that the respondents have scheduled the election of the Governing Body of the Society which has necessitated that the writ petition be heard on an early date.

The application is allowed.

The main writ petition is preponed from 01.11.2022 and is taken on board today itself.

Main case

Learned counsel appearing on behalf of the petitioner fairly contends that the petitioner has an alternative efficacious remedy in the form of approaching the Registrar General of Firms and Societies, Haryana to raise a challenge to the orders passed by the District Registrar, Firms and Societies, as well as order of State Registrar of Societies, Haryana. He seeks permission to withdraw the present writ petition with liberty to

approach the Registrar General of Firms and Societies, Haryana, in accordance with law.

He further prays that appropriate direction be issued to the Registrar General of Firms and Societies, Haryana, that in the event of petitioner preferring a petition before the Registrar General impugning the order dated 09.05.2022 (Annexure P-4) passed by the District Registrar, Firm and Societies and the order dated 27.01.2022 (Annexure P-3) passed by the State Registrar of Societies, Haryana, within a period one week along with any application seeking interim relief may be decided expeditiously and preferably within a period of 10 days of filing of petition in accordance with law.

The aforesaid request is accepted.

The present petition is permitted to be withdrawn with liberty to the petitioner to approach the Registrar General. In the event of any petition/interim application being appended along with the petition/appeal so preferred by the petitioner, the same shall be decided expeditiously and preferably within a period of 10 days of filing of the said petition, in accordance with law and after granting an opportunity of hearing to the concerned parties.

Disposed of accordingly.
