Learned counsel for the petitioner(s) very fairly submits that apart from the above mentioned petitions, a CWP-6683-2017 titled as Kiran Bala and another vs. State of Haryana and others was filed challenging the selection in question, which writ petition has been dismissed by a Coordinate Bench of this Court vide order dated 01.06.2018. Learned counsel for the petitioner(s) further submits that against the said judgment, LPA Nos.1044-1060 of 2018 have already been preferred.

Learned counsel for the respondents submits that once the selection has been upheld by a Coordinate Bench of this Court, the present writ petitions may also be disposed off in the same terms and conditions as in **CWP-6683-2017 titled as Kiran Bala and another vs. State of Haryana and others.**

Keeping in view the fact that a Coordinate Bench has already opined with regard to the claim of the similarly situated candidates qua the selection in question and petitioners were not able to controvert the fact that the petitioners herein and the petitioners in Kiran Bala (supra) are similarly situated, the present writ petitions are also disposed of in the same terms and conditions as in **CWP-6683-2017 titled as Kiran Bala and another vs. State of Haryana and others.**
