The instant petition under Section 482 of the Code of Criminal Procedure has been filed seeking issuance of direction to transfer the investigation to any independent agency in FIR No. 250 dated 23.06.2015 under Sections 419, 420, 467, 468 and 120-B of the Indian Penal Code, registered at Police Station Kherki Daula, District Gurugram.

Reply by way of affidavit of Suresh Kumar, HPS, Assistant Commissioner of Police, Manesar, Gurugram on behalf of respondents No. 1 to 3 has been filed. A relevant extract from the same reads as under:-

*“4. That the investigation was conducted by P/SI Aman and thereafter by SI Dinesh Kumar. During investigation, the relevant record was obtained from the complainant. Thereafter, the investigation was conducted by ASI Mahesh Kumar. It came forth that as per the mutation no.78, on 15.06.2020, Nathu S/o Chainsukh @ Chaina died and after his death, his elder brother Mohra Singh and Shaadi Ala*

*Numberdar introduced Anaro and after identifying her, the mutation of inheritance was got entered in her name. As per available record, Anaro @ Jawahar Kaur @ Anar Kaur had died on 05.10.1978.*

*5. That is also came forth during investigation that the persons who had committed the fraud i.e. Mohra Singh and Shadi Ala Numberdar have also died years ago. However, their death certificate could not be obtained due to passage of a long time. The fake Anaro also could not be found despite making enquiry about her and searching her. It has also come forth from the record that as per GPA vasika no.104 dated 15.10.1966, the fake Anaro had appointed one Harnarain S/o Durjan Singh as her attorney. The witnesses in the fake GPA are Mam Chand Numberdar R/o Nakhrola and Ganpat R/o Nakhrola. The GPA holder Harnarain has also found to have died in the month of September, 1973. The witnesses Mam Chand and Ganpat have also been found to have died long ago.”*

In view of the above, learned counsel appearing for the petitioner states that he does not press the instant petition, at this stage, but liberty may be granted to the petitioner to take recourse to the alternative remedy(ies), available in accordance with law.

Dismissed as not pressed with liberty as aforesaid.
