The petitioner, through instant petition under Section 482 Cr.P.C. seeking following reliefs in FIR No. 0044 dated 29.06.2022, under Sections 341, 323, 506, 34 IPC (Section 324 and 326 IPC added later on vide DDR No.033 dated 28.07.2022), registered at Police Station Sudhar, Tehsil Jagraon, District Ludhiana Rural, Punjab:-

(1) For handing over the investigation of the above said case to any independent investigating agency.

(ii) Direct the official respondents to protect the life and liberty of the petitioner and his family members from the hand of the accused persons/respondents No.4 to 6, who are giving life threatening to the petitioner and his family members.

(iii) To issue appropriate directions to the respondents No.1 to 3 to arrest the accused persons/respondents No.5 and 6 involved in the above-said FIR as they have committed non-bailable and cognizable offences as per medical record.

(iv) To direct the respondents to file/present the final investigation report u/s 173 Cr.P.C. in the Court.

(v) To pass any other appropriate orders or directions, which this Hon'ble Court deems fit in the facts and circumstances of the case and to secure justice to the petitioner and complainant in the above said FIR.

Learned counsel for the petitioner, at the outset, states that she does not want to press the other prayers except directions to Senior Superintendent of Police, Ludhiana Rural to look into the matter and decide representation dated 03.08.2022 (Annexure P-5).

Notice of motion.

On the asking of the Court, Mr. Ajay Pal Singh Gill, learned Deputy Advocate General, Punjab, who is present in Court, accepts notice on behalf of the respondent-State and very fairly states that he has no objection if the Senior Superintendent of Police, Ludhiana Rural is directed to look into the matter in view of representation dated 03.08.2022 (Annexure P-5) made by the petitioner.

In view of the present facts and circumstances, the present petition is allowed and the Senior Superintendent of Police, Ludhiana Rural is directed to look into the matter and take appropriate decision on representation dated 03.08.2022 (Annexure P-5) made by the petitioner.
