Learned State counsel submits that the petitioners herein have already been acquitted vide judgment dated 05.08.2015 of this Court. However, the present petition is lying pending merely for the compliance of directions to conduct and also to initiate remedial steps to rectify the error and to send report within six months from the date of judgment.

State has filed affidavit by way of affidavit on behalf of the Registrar-cum-Deputy Commissioner, Amritsar dated 15.01.2019 stating that the enquiry has been conducted. According to the said enquiry report, the Registry Clerks were found to be negligent but no action could be taken against them since all of them have died. It has also been referred in paras 4 to 6 of the said affidavit with regard to correction of entries on the endorsement in compliance of the directions of this Court and the same read as under:-

*“3. That the deponent has taken the report on record and passed an order through Assistant Commissioner (General) Amritsar regarding negligence of registry clerks but no action*

*can be initiated against these negligent employees as all three are dead now. (Annexure R-II).*

*4. That the Sub Registrar Amritsar-II has corrected the entry on the endorsement on 8.11.2018 as per directions passed by Hon'ble High Court. (Annexure R-IV).*

*5. That deponent vide letter No.EA/BC2/5678 dated 11.12.2018 has requested the Financial Commissioner (Revenue), being competent authority to take appropriate disciplinary action against the negligent Sub Registrar, Gurnam Singh who registered the sale deed in question and signed an endorsement where name of owner Amar Singh was mentioned wrongly instead of attorney Joginder Singh. (Annexure R-III)*

*6. That Financial Commissioner (Revenue) vide memo No.5/309/18/(6)786 Chandigarh dated 14.01.2011 has written to deponent that the concerned Sub Registrar cum Tehsildar Gurnam Singh who was promoted as District Revenue Officer retired on 31.08.2009 and had died on 20.07.2010. Therefore, no disciplinary action can be taken against the negligent Sub Registrar cum Tehsildar.”*

In view of the position explained above by way of affidavit dated 15.01.2019, Registry need not to list these petitions again in future as the directions stand complied with.

IOINs stand disposed of.
