1. This order shall dispose of the aforesaid two petitions filed on behalf of Prabh Sharan Singh & another as well as Sukhpal Singh & another, seeking grant of anticipatory bail in respect of a case registered vide FIR No.0477 dated 27.07.2016 at Police Station Asandh, District Karnal, under Sections 148/149/302/341/307 IPC

and Sections 27/54/59 of the Arms Act, wherein they have been summoned by the trial Court with the aid of Section 319 Cr.P.C.

2. Vide consolidated order dated 24.09.2021 passed in both the petitions, the petitioners were directed to appear before the trial Court within a week.
3. It has been informed that all the petitioners pursuant to the aforesaid direction have since appeared before the trial Court and are regularly appearing.
4. Having regard to the aforestated position, wherein the petitioners have been summoned with the aid of Section 319 Cr.P.C., it goes without saying that they are not required for any kind of custodial interrogation, as investigation had already concluded. The petitioners have already appeared before the trial Court. In these circumstances, both the petitions merit acceptance and are hereby accepted. The interim directions issued by this Court vide order dated 24.09.2021 are hereby made absolute.
5. Needless to mention, the trial Court would be at liberty to impose any other condition as deemed fit so as to ensure regular appearance of the petitioners before the trial Court.
