Instant petition has been filed under Section 438 of the Code of Criminal Procedure, 1973 for grant of anticipatory bail in FIR No.86 dated 03.06.2022, registered for offences under Sections 304-B and 34 of the Indian Penal Code, 1860, at Police Station Garhshankar, District Hoshiarpur, Annexure P-1.

State counsel has filed the affidavit dated 15.09.2022 of Deputy Superintendent of Police, Sub-Division Garhshankar, District Hoshiarpur, which is taken on record. Its relevant extract is as under:-

“7. That it is submitted that Bimal Kumar son of Puran Singh R/o Kungrat, District Una, submitted an application bearing No.1137-SSP, dated 08.06.2022 to SSP, Hoshiarpur alleging the innocence of the accused

persons in the present FIR. The said application was marked for inquiry to the deponent. On this, the deponent conducted inquiry into the matter of the present case and found Sheelo wife of Jaswant Rai, Neeraj daughter of Jaswant Rai and Aman wife of Sanjiv Kumar to be innocent in the inquiry and the deponent found Balwinder Singh to be guilty of committing the offences of the present FIR. The deponent also found that offence U/s 304-B, 34 IPC is not made out in the present FIR and offence U/s 306 IPC is made out as deceased Jaspreet Kaur was found to have committed suicide due to suspicion on her character by accused Balwinder Singh and due to arguments with Balwinder Singh for living separately in the house. The inquiry report was approved by SSP, Hoshiarpur.

8. That it is submitted that after completion of investigation the challan of the present case was presented in the court of Ld. SDJM, Garhshankar on 05.08.2022. Now the case is pending in the court of Sh. Lovedeep Hundal Ld. SDJM, Garhshankar on 15.09.2022 for appearance.”

In view of above, counsel for the petitioner submits that the petition has become infructuous.

Dismissed as having been rendered infructuous.
