Learned counsel for the petitioner submits that the petitioner is challenging the order dated 15.07.2022 (Annexure P-1) by which, the petitioner has been transferred from Batala to Civil Hospital Samrala and the prayer of the petitioner is that there are posts, which are lying vacant at nearby station where the petitioner can be adjusted and therefore, the said prayer of the petitioner be taken into consideration and appropriate direction be issued to the respondents.

Learned counsel for the petitioner further submits that the petitioner can be accommodated at PHC Gunopur as well as PHC Nainowal Jindar in District Gurdaspur and the petitioner has already made a representation in the said regard on 26.07.2022, a copy of which has been appended with this petition as Annexure P-7 and the petitioner will be satisfied at this stage, in case a time bound direction is issued to the respondents to decide the said representation by passing an appropriate speaking order.

Notice of motion.

Mr. Inderpreet Singh Kang, learned Assistant Advocate General, Punjab, who is present in the Court, accepts notice on behalf of the respondents and raises no objection in deciding the representation dated 26.07.2022 (Annexure P-7) in a time bound manner by passing an appropriate speaking order.

Without commenting upon the merits of the case or about the entitlement of the petitioner for the relief which has been claimed by him in the representation dated 26.07.2022 (Annexure P-7), the present writ petition is disposed of with a direction to respondent No.2 to decide the representation dated 26.07.2022 (Annexure P-7), within a period of four weeks from the receipt of copy of this order.
