By this common order, the above mentioned writ petitions are being disposed of as all the writ petitions involve the same question of law and similar facts.

Learned counsel for the parties are agreeable that the question of law raised in these writ petitions is covered by the decision of the Coordinate Bench of this Court in **CWP-14553-2021** tilted as **Sandeep Kumar and others vs. State of Haryana and another** decided on 02.06.2022 and prays that the present writ petitions be also disposed of in the same terms and conditions.

Ordered accordingly.

Keeping in view the fact that the petitioners are already continuing at their present place of posting as of now and the respondents are going to decide their claim by passing an appropriate speaking order, in order to avoid prejudice to any party, till the decision is taken by the respondents in terms of the order passed in **CWP-14553-2021** tilted as **Sandeep Kumar and others vs. State of Haryana and another** decided on 02.06.2022, the petitioners are allowed to continue at their present place of posting. However, the same will be subject to the satisfactory work and conduct of the petitioners and the same is administratively possible to adhere.
