The petitioners, who were working on various posts of Class-III and IV on contractual basis, have challenged their termination orders and prayed for a direction to the respondents to allow them to join on duties.

Learned counsel for the petitioner(s) submits that the petitioner(s) shall be applying to the Haryana Kaushal Rozgar Nigam Ltd. for their adjustment on suitable posts and a direction may be issued to the respondents to take them on the portal of the Haryana Kaushal Rozgar Nigam Ltd. after due verification of their experience.
