Instant appeal has been filed under Section 260A of the Income Tax Act, 1961 against the order of the Income Tax Appellate Tribunal, Delhi Bench dated 22.01.2021 passed in ITA No. 3219/Del/2018 for the assessment year 2014-15.

Having heard counsel at length and having perused the pleadings on record, we are of the considered view that the issue raised in the instant appeal would be covered in terms of common judgment dated 10.12.2019 passed by a Co-ordinate Bench of this Court in a bunch of ITAs including **ITA-8535-2018 (Principal Commissioner of Income-Tax, Faridabad vs. M/s Knorr-Bremse India Pvt. Ltd.)**.

Accordingly instant appeal is dismissed in terms of judgement
