Learned counsel for the petitioners argues that in the present case, the transfer drive which has been undertaken by the respondents, the petitioners have not been posted anywhere despite submitting the option and now, the schools where the posts are lying vacant, are to be filled in another round of the transfer drive. Learned counsel for the petitioners submits that though the petitioners have no objection in participating in other rounds of the transfer drive but the only prayer of the petitioners is that option for all the posts which are lying vacant including the posts which could not be filled up in earlier transfer drives, be open for option to the petitioners so that no grievance of the petitioners remains with regard to the transfer of the petitioners.

Learned counsel for the petitioners submits that apart from the said, the other grievance of the petitioners is that they have not completed five years service at the present place of posting and keeping in view the order passed by the Coordinate Bench of this Court in ***CWP-15108-2021 titled as Vikram Singh and others vs. State of Haryana and others decided***

Notice of motion.

Mr. Harish Nain, Assistant Advocate General, Haryana, who is present in the Court, accepts notice on behalf of the respondents.

Learned counsel for the respondents submits that he has instructions to submit that all the posts which remained unfilled in earlier transfer drive will be put up for option in the upcoming round, of the transfer drive if any and the petitioners can opt for the same. Learned counsel for the respondents further submits that in case, the petitioners are of the view that any post which the petitioners intend to opt for are lying vacant, they can mention the name of the said school and represent, which request will also be considered and if found feasible, those posts will be made available in the upcoming rounds of transfer drive if any.

Learned counsel for the petitioners submits that the petitioners have already submitted representations (Annexures P-6 to P-11/A) wherein, the petitioners have also given the details of the schools where the posts are lying vacant and for which the petitioners should also be allowed to opt for.

Learned counsel for the respondents further submits that appropriate decision on the representations (Annexures P-6 to P-11/A) will be taken within a period of 10 days from today and appropriate order will be passed regarding the concern raised by the petitioners therein and till the same is done, the petitioners will be allowed to continue at the present place of posting.

Learned counsel for the petitioners submits that keeping in view the statement of the learned counsel for the respondents, no further grievance of the petitioners survives in the present petition and the same

may kindly be disposed of having been not pressed any further.

Ordered accordingly.
