ARVIND SINGH SANGWAN, J. (Oral)

Prayer in this petition is for transfer of the petition filed by respondent No.1-husband under Section 13 of the Hindu Marriage Act, pending before the Family Court, Sonipat to the competent Court of jurisdiction at Jhajjar.

While issuing notice of motion, following order was passed by this Court on 15.11.2021: -

“Learned counsel for the petitioner would contend that the petitioner has to travel a distance of approximately 50

kilometres one way in order to attend the proceedings before the concerned Court at Sonipat. It is further contended that the petitioner has two minor children who are residing with her. He would further contend that a petition under Section 125 of the Code of Criminal Procedure, 1973 for grant of maintenance along with an application for registration of criminal case is also pending in the Court concerned at Jhajjar.”

Learned counsel has relied upon the judgments **Sumita Singh Vs. Kumar Sanjay, 2002 SC 396** and **Rajani Kishor Pardeshi Vs. Kishor Babulal Pardeshi, 2005(12) SCC 237**, wherein the Hon’ble Supreme Court observed that *while deciding the transfer application, the Courts are required to give more weightage and consideration to the convenience of the female litigants and transfer of legal proceedings from one Court to another should ordinarily be allowed, taking into consideration their convenience and the Courts should desist from putting female litigants under undue hardships.”*

Learned counsel has further relied upon **N.C.V. Aishwarya Vs. A.S. Saravana Karthik Sha, 2022 Live Law (SC) 627**, wherein the Hon’ble Supreme Court held as under: -

“The cardinal principle for exercise of power under Section 24 of the Code of Civil Procedure is that the ends of justice should demand the transfer of the suit, appeal or other proceeding. In

matrimonial matters, wherever Courts are called upon to consider the plea of transfer, the Courts have to take into consideration the economic soundness of both the parties, the social strata of the spouses and their behavioural pattern, their standard of life prior to the marriage and subsequent thereto and the circumstances of both the parties in eking out their livelihood and under whose protective umbrella they are seeking their sustenance to life. Given the prevailing socioeconomic paradigm in the Indian society, generally, it is the wife's convenience which must be looked at while considering transfer.

Further, when two or more proceedings are pending in different Courts between the same parties which raise common question of fact and law, and when the decisions in the cases are interdependent, it is desirable that they should be tried together by the same Judge so as to avoid multiplicity in trial of the same issues and conflict of decisions.”

As per office report, the respondents are served, however, there is no representation on behalf of respondent No.1-husband.

Learned counsel for respondent No.2 has no objection, in case the petition filed by respondent No.1-husband is transferred from Sonipat to Jhajjar.

It is well settled that while considering the transfer of a

matrimonial dispute/case at the instance of the wife, the Court is to consider family condition of the wife, custody of the minor child, economic condition of the wife, her physical health and earning capacity of the husband and most important, convenience of the wife i.e. she cannot travel alone without assistance of a male member of her family, connectivity of the place to and fro from her place of residence as well as bearing of the litigation charges and travelling expenses.

After hearing the counsel for the parties, considering the fact that the petitioner will have to bear the litigation expenses and transportation expenses and in view of the judgments in **Sumita Singh's** case (supra), **Rajani Kishor Pardeshi's** case (supra) and **N.C.V. Aishwarya's** case (supra) passed by the Hon'ble Supreme Court, this Court deem it appropriate to allow the present petition, subject to the following conditions:-

1. *The petition filed under Section 13 of the Hindu Marriage Act, pending before the Family Court, Sonipat will be transferred to the competent Court of jurisdiction at Jhajjar.*
2. *The District Judge, Jhajjar will assign the said petition to the competent Court of jurisdiction.*
3. *The Family Court, Sonipat is directed to transfer all the record pertaining to the aforesaid case to District Judge, Jhajjar.*
4. *The parties are directed to appear before the Family Court, Jhajjar within a period of 01 month from today.*
5. *The Family Court, Jhajjar will make all the endeavour to refer the case before the Mediation and Conciliation Centre for exploring the possibility of amicable settlement between the*

parties.

6. *The Court concerned, where the litigations between the parties are pending, will accommodate them with one date in one calender month.*

Present petition is disposed of accordingly.
