These petitions have been filed by the petitioner for the transfer of investigation in case FIR No.170 dated 13.05.2021, under Sections 188 & 120-B of IPC and Section 61 of the Punjab Excise Act, 1914 (Haryana Amendment Bill, 2000) and Section 51 of Disaster Management Act, 2005, registered at Police Station SGM Nagar, Faridabad (Annexure P-3) and in case FIR No.327 dated 09.07.2022 under Section 61 of the Punjab Excise Act, 1914 (Haryana Amendment Bill, 2000) registered at Police Station Dabua, Faridabad (Annexure P-4), to an independent Agency, by constituting an Special Investigating Team of Officials outside District Faridabad.

In Para-5 of the Status report, filed by way of an affidavit on behalf of respondents No.1 to 4, 6 & 7, it has been stated that vide order dated 29.05.2021 of the Deputy Commissioner of Police, NIT Faridabad, Special Investigating Team was constituted consisting Assistant Commissioner of Police, NIT Faridabad and SHO, Police Station SGM Nagar, Faridabad to investigate the matter.

Learned counsel for the petitioner submits that since respondent No.5 is posted in District Faridabad and is influencing the investigation, therefore, the investigation be transferred to other District outside Faridabad or in the alternate, let the Special Investigating Team as has been constituted vide order dated 29.05.2021, conduct the investigation under the overall supervision of Commissioner of Police, Faridabad.

Keeping in view of the facts and circumstances as has been noticed above, it is directed that the Special Investigating Team as has been constituted by the Deputy Commissioner of Police, shall conduct the investigation under the overall supervision of the Commissioner of Police, Faridabad and conclude the same within a period of six months and report to this effect shall be filed before the Registrar of this Court.

Disposed off, accordingly.
