The petitioners have approached this Court seeking protection of their life and liberty on the averments that they are living together in a live-in relationship against the wishes of respondents No.6 to 10 and the petitioners are apprehending threat to their life and liberty at their instance.

Notion of motion was issued on 17.11.2021 and the respondent/State was directed to file a detailed reply with regard to the martial status as well as custody of children of petitioner No. 1

On the last date of hearing i.e. 21.02.2022, the following order was passed :-

“.....It is stated by both the petitioners that they are willing to keep all the three children of petitioner No.1 having born from her earlier marriage with Gurmail Singh. They have requested that on the next date of hearing, they will bring the children also in order to see their willingness to stay with them or with respondent No.6-Gurmail Singh.

Adjourned to 24.03.2022.

The petitioners along with children are directed to remain present on the next date of hearing either through video conferencing or the case may be.

In the meanwhile, respondent No.2-Senior Superintendent of Police, Ferozepur, is directed to look into the grievances of the petitioners as set out in the petition and also expressed in the representation dated 06.11.2021 (Annexure P-4) and take appropriate action for protection of their life and liberty as may be warranted by the circumstances.....”

In compliance to the aforesaid order, both the petitioners along with children of petitioner No. 1 have come present before this Court through Whats App Video Call.

During interaction with the children, they have stated that they are happy to live with their mother and do not want live with their father Gurmail Singh.

The petitioners have reiterated their prayer for grant of protection of their life and liberty at the hands of the private respondents, with a further prayer that they be restrained from interfering in the peaceful live-in relationship of the petitioners.

Since the requisite orders for grant of protection to the petitioners has already been given to respondent No. 2- Senior Superintendent of Police, Ferozepur on the previous date of hearing i.e. 21.02.2022, no further action is required to be taken and the present petition is disposed of accordingly.
