**CM-368-CWP of 2022 in/and CWP No. 22341 of 2020**

Prayer in this application is for withdrawal of this writ petition in view of order dated 01.10.2021, Annexure A-1, whereby the applicant-petitioner has been reinstated to the post of Clerk.

This writ petition has been filed by the applicant-petitioner for quashing of order dated 18.03.2011, Annexure P-1, passed by the Chief Administrator, whereby the petitioner has been dismissed from service due to judgement of conviction and order of sentence dated 25.02.2011 passed by the learned Additional Sessions Judge, Hisar.

It is submitted that the appeal preferred by the applicant-petitioner against her conviction was accepted vide decision dated 30.07.2018 by a Coordinate Bench of this High Court. Furthermore, the Enquiry Officer, had exonerated co-accused-Devi Lal, of all charges and the charge sheet was dropped qua him. Applicant-petitioner has been reinstated in service after withdrawal of dismissal order vide order dated 30.09.2021, endorsed on 01.10.2021. Her suspension period has been directed to be treated as duty period for all intents, subject to withdrawal of this writ petition.

Keeping in view the above, CM-368-CWP of 2022 is allowed and CWP No. 22341 of 2020, is dismissed as withdrawn.
