Present petition has been filed under Article 226 of the Constitution, *inter alia*, for quashing of the impugned order dated 25.03.2019 (P-1), passed by the Chief Information Commissioner, Punjab in an appeal.

In pursuance of order dated 18.10.2022, additional affidavit dated 14/15.11.2022 of Sh. Amit Kumar Panchal, Additional District Election Officer-cum-Additional Deputy Commissioner (Development), Ludhiana on behalf of respondent Nos.5 & 6 has already been filed and para 2 thereof reads as under:-

That in compliance of the order dated 18/10/2022, the Deputy Commissioner-cum-District Election Officer, Ludhiana on dated 04-11-2022 has issued the following certificate to the petitioner:-

Reference:

1) Hon’ble Punjab & Haryana High Court order dated 18.10.2022 in CWP-25991 of 2019 (Faqir Singh Vs. State of Punjab)

2) Additional Deputy Commissioner (Gen)-cum-1st Appellate Authority under RTI Act, 2005 Ludhiana order dated 31.01.2019 endorsement No.1501/PB dated 11.03.2019.
