This is a first petition under Section 438 Cr.P.C. for grant of anticipatory bail to the petitioner in FIR no.26 dated 25.09.2022 registered under Sections 420, 406, 409, 465, 467, 471, 120-B IPC at Police Station Vigilance Bureau, Patiala District Patiala.

On 21.10.2022, this Court was pleased to pass the following order:-

“Learned counsel for the petitioner inter alia contends that in the present case, there are four allegations which are primarily made in the FIR and the only allegation with respect to the release of Rs.28,800/- against vehicle bearing registration No.PB-13AB-7345 for a period 23.02.2017 to 31.03.2017 which is alleged to have been used for personal purposes of one Bhagirath Rai Goyal, has been levelled against the present petitioner. It is further submitted that the petitioner had participated in the tender process alongwith two other persons and the petitioner had given the lowest tender, which was accepted. It is contended that the log book which was duly certified by the Executive Officer, Municipal Council, Sunam had been prepared and the allegations to the

contrary in the FIR are incorrect and that the vehicle of the petitioner was used in the year 2018 and in fact, amount is due towards the petitioner from the Municipal Council, Sunam. It is further contended that the present FIR has been registered due to political considerations. It is argued that the petitioner is not involved in any other case. It is also contended that the petitioner in order to show his bona fide, is ready to deposit an amount of Rs.28,800/- with the Municipal Council, Sunam within a period of eight days from today without admitting his liability.

In the meantime, in the event of arrest, the petitioner shall be released on interim bail subject to his furnishing personal bonds and surety to the satisfaction of Arresting/Investigating Officer. However, the petitioner shall join the investigation as and when called upon to do so and shall abide by the conditions as provided under Section 438(2) Cr.P.C.

The petitioner is directed to deposit an amount of Rs.28,800/- with the Municipal Council, Sunam within a period of eight days from today and produce the receipt regarding the same on the next date of hearing.

It is made clear that in case, the said amount is not deposited within a period of eight days from today, then the present interim relief granted in favour of the petitioner would be liable to be vacated.

The payment of the amount of Rs.28,800/- with the Municipal Council, Sunam would not be construed as an admission of guilt by the petitioner.

Learned counsel for the petitioner has submitted that in pursuance of the said order, the petitioner has joined the investigation and has also deposited an amount of Rs.28,800/- with the Municipal Council, Sunam.

Learned State counsel has submitted that the petitioner has joined investigation and is not required for further investigation and has

with the Municipal Council, Sunam.

Keeping in view the above said facts and circumstances moreso, the facts which have been noticed in the order dated 21.10.2022, and also the fact that the petitioner has joined the investigation and is not required for further investigation and the fact that the petitioner has deposited an amount of Rs.28,800/- with the Municipal Council, Sunam, the present petition is allowed and the interim order dated 21.10.2022 is made absolute.

Nothing stated above shall be construed as an expression of opinion on the merits of the case and the trial would proceed independently of the observations made in the present case which are only for the purpose of adjudicating the present bail petition.
